## **Topic: Awaken your dormant artistic inner voices**

I'm frequently asked, 'have you always been an artist?'  
The answer is 'yes'! Artistic tendencies lay dormant in us until they're awakened. For some the awakening comes early on in life, for others this happens after retirement

While I was busy raising our two sons (yes, they played with crayons at 6 months!) my artistic outlet focused on animal fiber. I would pick up raw alpaca or sheep fiber from the farm, cleaned them to spin into yarn for weaving or knitting.  
In 2010 I switched to painting full-time. In 2016 I established my studio/Gallery at 1200 E Woodhurst Drive.

I receive my inspirations from any number of sources. It can be a color I encounter, an object I see, light playing an enchanting game on some object, sunsets, flowers, fall leaves....
