"Major Asset, Major Pain: Estate Planning for IRA's"

Speaker: Susan Teson

Susan B. Teson is Deputy Chief Fiduciary Officer, Senior Legal Counsel and Senior Vice President with UMB Bank, n.a., Kansas City, Missouri. Ms. Teson has been a member of the Missouri Bar since 1982. With UMB since 1992, she manages UMB's Private Wealth Management Legal, Fiduciary Tax, Real Estate and Unique Assets Departments. Ms. Teson received her Bachelor of Arts degree in English, with distinction, from the University of Missouri-Kansas City in 1976 and her Juris Doctor degree, with distinction, from the University of Missouri-Kansas City School of Law in 1982. She was a member of the Bench & Robe Society, the UMKC Law Review and Editor-in-Chief of the UMKC Law Review in 1981-82. She has been a Certified Financial Planner since 1995. Additional professional City Metropolitan Bar affiliations include the Kansas Association, the Estate Planning Society of Kansas City and the Kansas City Estate Planning Symposium Board. She is also a member of the Missouri Bar's Probate and Trust Law Committee, including its subcommittee which studied the Uniform Trust Code for adoption in Missouri and has been active in commenting about the UTC in Nebraska, Oklahoma, Colorado and Kansas. She most recently chaired the Power of Appointment subcommittee which drafted the Missouri Uniform Power of Appointment Act, adopted by the Missouri legislature in 2016. She co-authored two articles about the Missouri Powers of Appointment Act published in the Missouri Bar Journal in 2017. Ms. Teson has served as an adjunct professor at the UMKC Law School teaching estate planning and drafting since January, 2017.
